Terms and Condition for Becoming an LCP-Certified Leadership Coach

As an LCP-certified leadership coach/consultant, you have been trained to use the Leadership Capacity Program[™] and the LCP Coaching Accelerator[™] and have access to the coaching tools available in the LCP Coaching Centre at <u>www.lcp-global.com</u>. You have qualified to buy and use LCP[®] for your immediate clients in the country in which you were certified. You are not authorized to certify others to use LCP for their clients. If you agree to the terms and conditions of this certification agreement, you are permitted to say that you are an LCP-certified coach/consultant and can use the LCP Coaching Accelerator. If you use the registered trademark beyond this context (i.e. in your marketing materials or for promotional purposes on your website) it will need to be clear that LCP is a registered trademark of LCP Global Pty Ltd.
